

## SPECIFIC CONDITIONS APPLICABLE TO CONTRACTING TERRITORIAL .ES TOP-LEVEL DOMAINS

The present specific conditions complement and develop the general conditions of the domain registration contract and form an integral part of the same.

### 1.- Identifying data which complement the general conditions

- **Definition:** Territorial domains are top-level domains relating to a country or territory code (Country Code Top Level Domain: "Cctld"). For the purposes of the present conditions, these abbreviations refer to the classification in the domain name system, represented by a code of two letters assigned pursuant to the Standard ISO 3166-1 for the representation of country and territory names.
- **Domain name Regulator:**
  - ICANN ([www.icann.org](http://www.icann.org))
- **Registry Operator:**
  - Red.es
- **Body responsible and regulations for domain name attribution conflict resolution:** Dispute Policy (Uniform Domain-Name Dispute-Resolution Policy) as laid down in the regulations on conflict resolution established by Internet Corporation for Assigned Names and Numbers (ICANN) on the 24th of October 1999. ([www.icann.org/udrp/udrp.htm](http://www.icann.org/udrp/udrp.htm))

### 2.- Registry restrictions:

For further information on the Registry restrictions incorporated hereby, and which form an integral part of the contractual conditions applicable, the applicant for the domain can refer to [www.red.es](http://www.red.es)

### 3.- Declaration by the Client

The Client hereby assumes sole liability for the following declarations:

- That they have read, understood and accept the text attached as Appendix I to the present specific conditions, which sets out the regulations for the assignment of domain names under ".es" in force.
- That all the information furnished in the present application is accurate, complete and correct, errors and omissions in good faith excepted.
- That they are aware, and accept, that any false statement in the data furnished in the present application may be cause for rejection of the same, or cancellation of the domain name at any moment if already registered, and in the latter case, the domain name might be subsequently registered by another client in accordance with the established regulations and procedures. That to the best of their knowledge, the use of this domain name does not infringe

the intellectual or industrial property rights of any third party, does not represent unfair competition, nor in any other way infringe any other right of any class of third party.

- That they bear full liability for the consequences of any question arising over the right to use the chosen name.
- That they hold sole liability for the choice of this domain name and its subsequent maintenance.
- That they are aware, and accept, that registration of the proposed domain name does not confer any legal rights over the same.
- That they agree to defend, compensate and make restitution to, Acens and Red.es, and the directors, officials, employees and agents of each and every one of the same, for any loss or expense, including attorney's fees, arising from a claim by third parties or legal action relating to the domain name or the use made of the same. These damages shall be additional to any other damages demanded under the Dispute Policy.
- That they accept the conditions of the contract agreed by Acens with Red.es under which domains are registered automatically (published at [www.icann.org](http://www.icann.org))
- That acceptance of these conditions entails the acceptance of the Rules and Conditions laid down by the Internet domain name regulator [www.icann.org](http://www.icann.org). In particular, they accept the Dispute Policy ([www.icann.org/udrp/udrp.htm](http://www.icann.org/udrp/udrp.htm)).

## APPENDIX I

DOCUMENT BY WHICH THE APPLICANT FOR A DOMAIN NAME DECLARES THAT THEY ARE AWARE OF AND ACCEPT THE ASSIGNMENT RULES FOR DOMAIN NAMES UNDER ".es", CONSENTS TO THE TRANSMISSION OF THEIR PERSONAL DATA TO RED.ES FOR THAT PURPOSE, AND AUTHORIZES THE REGISTRATION AGENT TO ACT ON THEIR BEHALF

domain name \_\_\_\_\_ .es" (henceforth, "the Applicant") hereby declares that:

- They authorize the Registration Agent Acens, S.L.U. (henceforth, "the Registration Agent") to act on their behalf before RED.ES (henceforth, "the Registry Operator" or "the Assignment Authority", interchangeably), and to carry out all the actions necessary for the assignment and renewal of the domain name \_\_\_\_\_ .es" (henceforth, "the Domain Name"), including receipt of the corresponding communications.
- They authorize the Registration Agent to perform such actions as may be necessary to make, on their behalf, the payments corresponding to the assignment and management of the Domain Names, which may be due in successive years.
- The Registration Agent has informed them appropriately, and they are aware of the latest regulations and procedures in force, the terms and conditions, tariffs and form of payment and the technical requirements established for the registration of domain names under ".es" through the agency of an accredited Registration Agent, and they accept them in their entirety. In particular, the Applicant declares they are aware of the regulations, procedures, terms and conditions for the Registration of a Domain Name under ".es", which same are available at <https://www.nic.es/documentacion/lasleyes.html>.
