3.- Declaration by the Client

The Client hereby assumes sole liability for the following declarations:

- 1. That they fulfil the General Eligibility Criteria, in accordance with which they must be:
- A company whose registered address, central administration or principal centre of activity is within the European Community.
- An organization established within the European Community notwithstanding any national legislation applicable.
- An individual resident in the European Community.
- 2. That they shall notify the Registry Operator, through the Registration Agent, if and when they no longer fulfil these criteria.
- 3. That all the information furnished to the Registry Operator during the process of domain name registration is true, complete and accurate.





- 4. That the Domain Name registration application is made in good faith, for legitimate purposes, and does not infringe the rights of third parties.
- 5. That the domain name does not contravene public order or morality (for instance, it is not obscene or offensive) and it is not illegal.
- 6. That they will comply with the "Terms and Conditions" accessible at: http://www.eurid.eu/files/reg_pol_EN.pdf and the remaining regulations applicable during the period of validity of the domain name registration.
- 7. That they are aware, and accept, that any false statement in the data furnished in the present application may be cause for rejection of the same, or cancellation of the domain name at any moment if already registered, and in the latter case, the domain name might be subsequently registered by another client in accordance with the established regulations and procedures.
- 8. That to the best of their knowledge, the use of this domain name does not infringe the intellectual or industrial property rights of any third party, does not represent unfair competition, nor in any other way infringe any other right of any class of third party.
- 9. That they bear full liability for the consequences of any question arising over the right to use the chosen name.
- 10. That they hold sole liability for the choice of this domain name and its subsequent maintenance.
