

SPECIFIC CONDITIONS APPLICABLE TO CONTRACTING ccTLD DOMAINS

The present specific conditions complement and develop the general conditions of the domain registration contract and form an integral part of the same.

The present specific conditions are applicable to processing domain applications with Registry Operators with which Acens has not agreed a service provision contract, and therefore, the Applicant declares that they have visited the web of the Registry Operator, and are aware of and accept the terms and conditions laid down by the same.

1.- Identifying data which complement the general conditions

- **Definition:** ccTLDs are top-level domains relating to a country or territory code (Country Code Top Level Domain: "Cctld"). For the purposes of the present conditions, these abbreviations refer to the classification in the domain name system, represented by a code of two letters assigned pursuant to the Standard ISO 3166-1 for the representation of country and territory names.
- **Domain name Regulator:**
-ICANN (www.icann.org)
- **Registry Operator:** Entity responsible for the ccTLD domain requested. All the Registry Operators are listed at <http://www.iana.org/domains/root/db/>
- **Body responsible and regulations for domain name attribution conflict resolution:** Dispute Policy (Uniform Domain-Name Dispute-Resolution Policy) as laid down in the regulations on conflict resolution established by Internet Corporation for Assigned Names and Numbers (ICANN) on the 24th of October 1999. (www.icann.org/udrp/udrp.html)
- **Country where the Registry Operator is domiciled for the purposes of international transfer of data:**
-that of the Registry Operator.

2.- Registry restrictions

For further information on the restrictions of each of the ccTLD registries which are incorporated hereby and which form an integral part of the contractual registration conditions, the Applicant for the domain should refer to the website of the corresponding Registry Operator.

3.- Declaration by the Client

The Client hereby assumes sole liability for the following declarations:

- That all the information furnished in the present application is true, complete and correct, errors and omissions in good faith excepted.
- That they are aware, and accept, that any false statement in the data furnished in the present application may be cause for rejection of the same, or cancellation of the domain name at any moment if already registered, and in the latter case, the domain name might be subsequently registered by another client in accordance with the established regulations and procedures.
- That to the best of their knowledge, the use of this domain name does not infringe the intellectual or industrial property rights of any third party, does not represent unfair competition, nor in any other way infringe any other right of any class of third party. **acensTechnologies**
- That they bear full liability for the consequences of any question arising over the right to use the chosen name.
- That they hold sole liability for the choice of this domain name and its subsequent maintenance.
- That they are aware, and accept, that registration of the proposed domain name does not confer any legal rights over the same.
- That they agree to defend, compensate and make restitution to Acens, and any Registry Operator for the domain name requested, including the corresponding Registry Operator, and the directors, officers, employees and agents of each and every one of them, for any loss or costs, including attorney's fees, arising from a claim by third parties or legal action relating to the domain name or the use made of the same. These damages shall be additional to any other damages demanded under the Dispute Policy.
- That acceptance of these conditions entails the acceptance of the Rules and Conditions laid down by the Internet domain name Regulator: www.icann.org. In particular, they accept the Dispute Policy. (www.icann.org/udrp/udrp.html)
- That they accept the conditions contracted by Acens with the corresponding Territorial Registry Operator or designated intermediaries for managing the domain name application, including, where relevant, any specific or particular procedures relating to dispute resolution policies should these be different from those set out by ICANN.
